

**聖保羅男女中學附屬小學**

**幼稚園提名（助學）計劃 申請須知**

聖保羅男女中學附屬小學特設幼稚園提名（助學）計劃（下稱「助學計劃」），為品學兼優的幼稚園畢業生提供財政資助，確保具潛質的學生，不受經濟因素影響就學，名額約為小一學位的 5%（約 7 人）。

**申請資格及細則**

1. 基本申請資格：品學兼優及符合本校全數學費減免資格\*。
2. 獲提名學生須通過申請資格審核及面試，方可獲正式取錄。
3. 一經取錄及核實符合本校全數學費減免資格後，學生即可獲得全年全數學費減免，更可獲資助下列項目的費用：學童保母車服務、校服、書簿、校內午膳、一項繳費課外活動及樂器班學習課程等。

**提名及申請**

1. 有關幼稚園校長
  - a) 每所幼稚園校長可提名最多兩名學生申請入讀本校小一。請分別為每位申請人填寫一份提名表（附表格一及二）。如只提名一位申請人，請填表格一。
  - b) 校長請填妥助學計劃的提名表，簽署及蓋校印確認。提名表須於截止報名日期前交予申請人的家長，與入學申請表一併遞交。家長如透過網上申請，請將提名表作附件上載。
2. 有關申請人
  - a) 申請人須初步確定自己符合本校全數學費減免資格，並於截止日期前，把已填妥之提名表與入學申請表一併遞交。
  - b) 如獲邀參加第二輪面試，學生須遞交已填妥的減免學費申請表及相關文件。若所提供的資料不足或有失實虛報者，本校可能無法辦理有關入學申請。

**甄選及取錄**

獲提名學生須與其他申請人一起參與 9 月至 11 月舉行之小一學生甄選程序，經第一及二輪面試合格，方獲取錄。

**\*全數學費減免資格**

本校的學費減免計劃設有不同的減免學費類別，若學生的家庭可動用收入不高於基準可動用收入，他將有資格獲全數學費減免。以一個四人家庭為例，基準可動用收入為每年港幣\$331,500。詳情請參閱本校網頁有關學費減免申請指引及試算表。

**Kindergarten Nomination Scheme (Financially Disadvantaged Students)**

**NOTES TO APPLICANTS**

St. Paul's Co-educational College Primary School (SPCCPS) has introduced a kindergarten nomination scheme with a view to encouraging financially disadvantaged students to apply for admission. The School has put aside about 5% (around 7) of the primary one places for the scheme.

**Eligibility**

1. General requirements
  - a) Exemplary conduct and academic performance;
  - b) The family's disposable income qualifies for full fee remission\*.
2. Offer will be made to the nominees who have successfully passed the means test and the selection procedure.
3. Successful applicants through the scheme will enjoy a waiver of the school fee for the year. Moreover, they will be offered a bursary to help cover expenses on textbooks, school meals, school uniform and transportation; subsidies will also be provided for the musical instrument class and extra-curricular activities.

**Nomination and Application**

1. The Head of Kindergarten (The Head)
  - a) Up to two students may be nominated from each kindergarten. The Head should complete one Nomination Form for each nominee (Appendixes: Nomination Forms 1 & 2). If the Kindergarten is nominating only one candidate, please fill in Form 1.
  - b) The Head should sign with the school stamp on the Nomination Form, and return it to the parent of the applicant for submission together with the P1 Application Form by the application deadline. The parent may upload the Nomination Form as an attachment via the online application system.
2. The Applicant
  - a) The Applicant has to qualify for full fee remission upon submission, and submit his/her Nomination Form together with the P1 Application Form by the deadline.
  - b) Once invited to the second round of interviews, the Applicant should submit

the completed Fee Remission Application Form and relevant documents. Please note that the School may not be able to process the application in case of omission or misrepresentation of information.

### **Selection Procedure**

Nominees will be invited to interviews, together with other applicants, from September to November. Offer will be made to those who have successfully passed the two rounds of interviews.

### **\* Eligibility for Full Fee Remission**

There are different categories of fee remission. A child from a family whose family disposable income does not exceed the benchmark disposable income would qualify for 100% fee remission. For a family of 4 persons, the benchmark disposable income is HK\$331,500 per year. For details of the Fee Remission Scheme, please refer to our school website and the remission calculator.
